TSA 100% OGD ANNUAL BADGE AUDIT

Monday August 31st, 2020, the OGD TSA annual required badge audit concluded.

The numbers were:

* SIDA badges - 86 participated out of 89 SIDA badge holders 96.6%

* AOA badges - 1,037 participated out of 1,060 AOA badge holders 97.8%

The results look good, but to be honest ... I was sweating the last day.

The final results will be rechecked tomorrow for accuracy and then sent to TSA. Thank you for your efforts. An additional "thank you" to EAA and Ed McKenney. Their efforts saved several groups of badge holders from failure.

For next year's audit, I ask that you simply put your badge in an envelope and mail it back to us if you are going to be out of the area for an extended period. Just mail it to: Airport Manager, 3909 Airport Road, Ogden Utah 84405.

Returning your badge voluntarily will never be held against you and we will get you your badge back, as soon as you return. I am trying to find ways to make this easier for all involved. I will be reaching out to the badge groups that seemed to have the most difficulty in meeting the audit requirements.

NORTH TIE-DOWN APRON CONSTRUCTION UPDATE

The reconstruction of the north tie-down apron began on August 17th, 2020. The overall project is on schedule to be completed in mid-October. The seven new tie-down positions near the south run-up area were completed on Monday, August 31st. They are now in use, but they still need to be marked / painted in October.

The main area that is currently dug up, should be placing the six inches of base material this week and hopefully beginning paving the following week.

On Monday, September 14th until Friday September 24th, Taxiway Alpha will closed between Taxiway Charlie and Taxiway Delta. Expect some unusual routing from air traffic control during these days. After the tower closes, you will have to use Runway 03-21 to get around the construction, use good radio verbiage to let others know what your intentions are.

Just a reminder, the far north end of Phase 1 still has to be completed after the main area is paved. All new pavement will need to have the tie-down anchor points drilled and the concrete poured. Lastly, the lead in lines will still have to be painted.

BICKERING SISTERS

The OGD Airport Terminal Building restaurant is having a "soft" opening. They

The full restaurant will come next year. We will be replacing the Terminal Building roof, first. The roof construction will begin on Monday September 14th and should be completed towards the end of October.
