

OGD CONSTRUCTION UPDATE ON NORTH APRON RECONSTRUCTION

NORTH APRON RECONSTRUCTION

About six weeks ago, I sent out a mail chimp reminder that the Reconstruction of the North Apron, Phase One was going to begin. As with virtually all Airport construction projects, the work cannot be done without some level of disruption and inconvenience. This project is no exception.

Granite Construction is currently wrapping up the Phase One of the North Apron Reconstruction. Over the past 6 weeks, Granite has kept an aircraft taxi path open from many nearby hangars to the runways. On this coming Monday, July 26th, Granite will begin the second phase, and all access from several hangars to the runways will be cut off until August 23rd. This scheduled completion date is tentative, and it is dependent on the weather and conditions that are encountered in the soil under the existing pavement.

See the graphic below for the boundaries of the two phases and the approximate dates involved.

If you choose to use your aircraft during the Phase Two construction. I can offer you a free tie-down location during this construction. They can also use any personal contacts to house your aircraft elsewhere at OGD or another airport. Please contact the Airport Office if you are affected by the construction and need to be assigned a temporary tie-down location.

The point is that if you do not remove your aircraft from your hangars by next Monday, your aircraft will be trapped in your hangars and will not be able to get to the runways until the construction is completed.



BTW, all contractors doing work at OGD are licensed, bonded, and insured. Any damages that are believed to have been caused by the contractor, must be brought to the attention of the Airport Manager. It is difficult for me to know that someone's property has been damaged, if no one actually tells me. Please do not complain about it on social media. If you want it addressed, simply call me. Any and all claims will be investigated in depth and the contractor will be responsible for damages that they are determined to have caused.
