Executive Summary

Mayor Benjamin K. Nadolski will present his proposed Ogden City Budget for the Fiscal Year 2025-2026. The Council will accept the proposed budget for review and consideration. The Mayor's budget presentation and the line-item budget will be posted to the city's website [here](#) on or before May 7, 2025.

Background

Per [Utah Code §10-6-111](#), the Mayor must present a proposed budget for the upcoming fiscal year during the first Council meeting in May. Following the Mayor's presentation, the Council accepts the proposed budget for review. The Council holds a series of work sessions over the course of May and June to review the proposed expenditures for all departmental accounts and all major and minor funds. A tentative budget is adopted after holding an initial public hearing. At least one public hearing is held before adoption of the final budget.

During the budget hearings, the Council outlines proposed changes to the tentative and final budgets and accepts public input. Once the final public hearing is closed, the Council makes changes and adopts the final City budget. By State law, a final budget must be adopted by June 30 unless a property tax increase is under consideration, then the final budget must be adopted by September 1.
