# Fee Reduction and Scholarship Program

The goal of the Marshall N. White Community Center's Fee Reduction and Scholarship Program is to minimize the financial burden of program fees for low-income residents. Those whose income qualifies for this program will be able to register for programs at a reduced rate or, when scholarships are available, for free.

## IF APPLYING FOR CITYWIDE RECREATION FEE REDUCTION PROGRAM, EXEMPTIONS ARE AS FOLLOWS

Income verification MUST include photo ID **AND** a W-2 form, payroll statement OR tax return from the previous year.

Assistance is limited to those under the age of 18.

## WHO CAN APPLY?

Applicants MUST live within Ogden City limits. Applicants must qualify under the Family Income Guidelines listed on the back side of this page.

## HOW TO APPLY?

Complete the application on the back of this form and return to the front desk with verification of your proof of income and proof of address.

## WHAT KIND OF DOCUMENTATION IS NEEDED?

You will need to provide both proof of income and proof of residence in Ogden City. Please choose ONE form of verification for each category. For citywide recreation fee reduction, read the rules at the top of this page.

Proof of **Income** can be provided through providing ONE of the following documents:

- W2 form
- Payroll statement
- Most recent tax return
- Social Security Award/ Benefit Letter
- Or a letter from Ogden City School District noting your qualification for the free or reduced lunch on school district letter head.

Proof of **Residency** can be provided through providing ONE of the following documents:

- Utility bill that was issued within the last 3 months
- A current rental/ lease agreement in Ogden City
- Current property tax statement
- Or a letter from Ogden City School District verifying that you live in Ogden City and are not attending school through school choice outside district boundaries.

## WHAT PROGRAMS CAN I REGISTER FOR USING THIS PROGRAM?

The Marshall N. White Community Center's Fee Reduction and Scholarship Program covers all Marshall White Center programs (see Learn to Swim Scholarship Application for swim lessons) and up to 30% membership prices for those who qualify.

Other city recreation programs may be covered if you follow the instructions at the top of this form.

## IS THERE A DEADLINE?

Applications must be received and processed before you can register for a program. Processing can take between 1-2 weeks. No refund will be given for those who qualify for the program but have already paid for registration. A new application must be completed each year.

The application will be in effect for one year, beginning each July and ending in June. It will be necessary to reapply each July. The information on the application is confidential and will be used only to determine eligibility.

Approval of a fee reduction does not automatically register the person into the program. A "Registration Form" must still be completed and payment must be paid to be enrolled in the program.

## HOW WILL I KNOW IF I HAVE BEEN ACCEPTED?

Once you have turned in your application and your verification, you will receive an email notifying you of your eligibility for the program. Once you have been accepted into one or both programs, you will be informed of how to register.

## WHO CAN PARTICIPATE?

Anyone who meets the requirements and can provide verification.

Marshall N White Center: As funding allows.

## RULES AND GUIDELINES FOR PROGRAM FEE REDUCTION

### Attendance

It is expected that participants in the Marshall N. White Community Center's Fee Reduction and Scholarship Program have at least an 80% attendance in their registered program. Less than an 80% attendance will result in a suspension from the Marshall N. White Community Center's Fee Reduction and Scholarship Program for 1 calendar year. It is suggested that if you plan to take a vacation during a program, to wait until the next session to register. A petition may be made for any extenuating circumstances that resulted in suspension from the program.

### Behavior and Conduct

Those participating in the Marshall N. White Community Center's Fee Reduction and Scholarship Program should show a desire in wanting to participate in registered programs by having good behavior during the program and being an active participant in the registered activity. Major disruptions to a program may result in dismissal from the registered program and participation in the Marshall N. White Community Center's Fee Reduction and Scholarship Program.
