for Transportation Commission Funding

Dear Mayor and City Council,

Thank you for submitting your City's Moderate Income Housing report for this year in fulfillment of requirements set forth in State Code section [10-9a-408](#). The Housing and Community Development Division (HCDD) has reviewed the report and finds that the submitted report **complies** with the requirements set forth in section [10-9a-408](#).

As a city with a fixed guideway transit station, Ogden City is required to do one of the following:

- submit five strategy progress reports, if they include strategy U, either strategy G or H, and three more strategies in section [10-9a-403](#) (2)(b)(iii), OR
- submit three strategy progress reports, if they include strategy U, one of the strategies from X through CC, and one other strategy in section [10-9a-403](#) (2)(b)(iii).

Six strategies were found to comply with [10-9a-408](#).

In addition to your report being found compliant, State Code section [10-9a-408](#) (6) includes incentives for cities which go above and beyond the minimum compliance requirements, including qualifying to receive Priority Consideration for Transportation Commission Funds or projects described in Utah Code [72-1-304](#) (1)(a), for transportation projects within the boundaries of the Municipality. Ogden City has met the requirements of [10-9a-408](#) (6) for Priority Consideration of these funds within the boundaries of the municipality.
