 - v. **Consumer Price Index Source Amendment.** Proposed Ordinance 2015-28 amending the Ogden Municipal Code by amending Subsection 4-6-1.B.19; Subsection 4-6-1.B.20; and Section 9-1-6 to revise the source information for the Consumer Price Index adjustment relative to sanitary sewer, storm sewer, water, and refuse utility charges. **(Ordinance adopted, vote: 7-0)**

 - a. **Transportation Funding – HB362 Local Option Sales Tax.** Proposed Joint Resolution 2015-15 supporting the HB362 (2015) authorized 0.25% local option general sales tax dedicated to transportation, encouraging the County of Weber to submit the proposal to voters in November 2015, and encouraging voters to support the proposal.
